## **MIAMI WOODS PRAIRIE UPDATE**

### **A BREAKTHROUGH**

On June 10<sup>th</sup> a group of 31 volunteers from the Goldman Sachs Company led by eight intrepid North Branch volunteers broke through the buckthorn barrier into the Miami prairie. The riparian woodland from the Caldwell Avenue parking lot north to the prairie has been the target of four major special event workdays:

- Public Lands Day 2002 (80 volunteers/376 hours)
- Public Lands Day 2003 (42 volunteers /287 hours)
- Commissioner Suffredin May 2004 (89 volunteers /242 hours)
- Goldman Sachs (38 volunteers /227 hours)

In total, 249 volunteers worked 1132 hours to clear buckthorn from a 1,750 foot strip of river bluff northward from the parking lot between the river and the bike path. Big old oaks, hickories, white ash and other native trees – once obscured by brush – now have some welcome breathing space. Rare wildflowers such as Rue Anemone grace the bluff, growing with renewed vigor in the increased sunlight. Thus begins the renewal to a healthy oak woodland. Awesome; sends shivers down our spines.

### **CHICAGO CITY DAY SCHOOL SCORES A VICTORY**

Students from the Chicago City Day School are making great progress in clearing buckthorn and other invasive species from the river banks and nearby woods between the river and bike path. Starting at the Miami Woods Prairie in the spring of 2003 students from the 4<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> grades have visited three times and cleared brush from more than 900 feet to the north. The 371 volunteer visits have resulted in more than 500 working hours during the 12 work events.

The sense of value associated with the physical work accomplished is just part of the story, since the kids are also spending additional time

monitoring water conditions and observing nature. Hopefully these experiences will influence the kids and their families for years to come.

### **DUPAGE FOREST PRESERVE DISTRICT WINS NATIONAL CERTIFICATE OF EXCELLENCE**

The Forest Preserve District of DuPage County has recently been recognized with two national certificates of excellence, one for its ecological monitoring program and another for its management of the Tri-County State Park and Visitor Center.

The National Association of County Park and Recreation Officials announced that the DuPage District's long-term program studying multiple one-acre plots has won the 2004 Park and Recreation Environmental Certificate of Excellence.

Every year, NACPRO recognizes a park and recreation agency that achieves excellence in its endeavors to reclaim, restore, preserve or develop a natural area at the county level.

Between 1979 and 1985, the Dupage District staff established a number of one-acre plots in county woodlands to provide a "snapshot" of woodland plants' composition. The 25 years of data gathered demonstrate that unmanaged woodlands are deteriorating and that native species are being lost. Quantitative data confirm that non-native species and aggressive, native woody trees and bushes eventually dominate woodlands if left unchecked, leading to dark, thick woods that stifle oak trees' regeneration. The data have provided additional scientific support for ecosystem management, helping the District to formulate plans to manage woodland vegetation and replenish health in these communities.

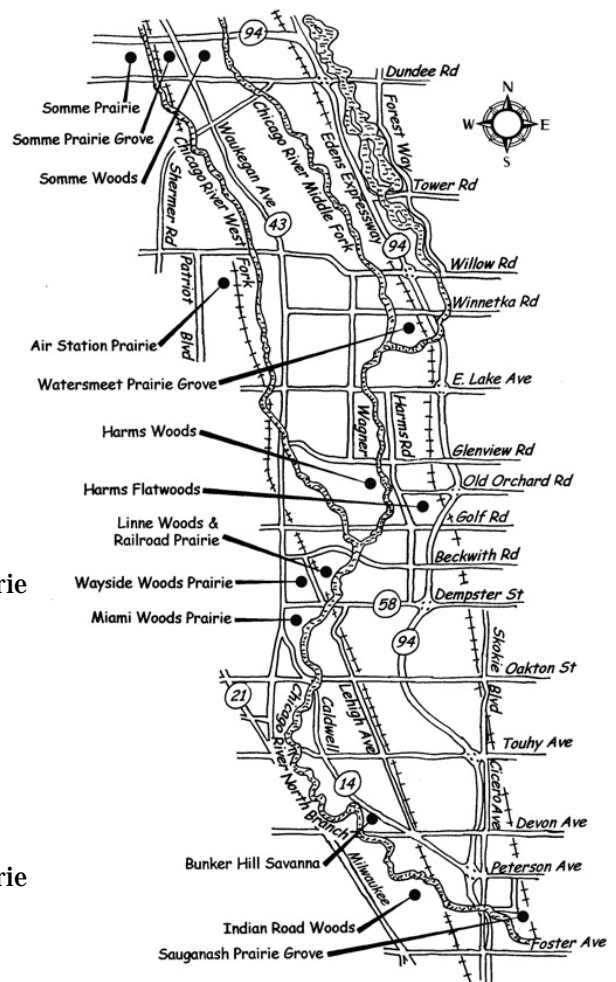

## DIRECTIONS:

**Air Station Prairie, Glenview** – From the Edens expressway; go west on Willow Road, past Waukegan Road and over the RR overpass. Turn south at the new traffic signals for Patriot Blvd. (The new main road through the redeveloped Naval Air Station). Turn east on Compass to the gate at the south end of the prairie. Patriot Blvd. is also accessible from the south via Lake Ave.

**Bunker Hill Savanna/Oxbow, Chicago** – Off Caldwell between Devon and Touhy; entrance located just opposite Tonty Street. For Bunker Hill Meet in first section of parking lot; for Oxbow, follow road until it turns north, then park along the west side.

**Harms Flatwoods, Glenview** – Meet at the Forest Preserve Grove parking lot on the west side of Harms Road, directly west of Old Orchard Road.

**Harms Woods, Glenview** – Meet at the Forest Preserve Grove parking lot on the west side of Harms Road, just south of Glenview Road.

**Indian Road Woods, Chicago** – Enter at the Indian Road Forest Preserve drive, on the east side of Central Ave, just north of Indian Road (approximately ½ mile south of Caldwell). Meet in the parking area at the far east end of the drive.

**Linne North** – Meet at the Wayside Woods Prairie parking lot. (See below for direction.)

**Miami Woods Prairie, Niles/Morton Grove** – Located on the east side of Caldwell, two blocks north of Oakton. Meet in the parking lot for Miami Woods.

**Sauganash Prairie Grove, Chicago** – Meet at the edge of the Forest Preserve along the south side of Bryn Mawr at Kilbourn, which is south of Peterson and east of Cicero.

**Somme Prairie Grove, Northbrook** – From the Edens Expressway, take Dundee Road two miles west to Waukegan Road. Go north a few hundred feet on Waukegan and turn left into the unpaved parking area by the sign “Somme Woods Prairie.”

**Somme Prairie Nature Preserve, Northbrook** – From the Edens Expressway, take Dundee Road 2½ miles west (past Waukegan) to Western. Turn north and park in the post office parking lot.

**Somme Woods, Northbrook** – From the Edens Expressway, take Dundee Road two miles west and turn right into Somme Woods parking lot (just before the light at Waukegan Road).

**Watersmeet Prairie Grove, Northfield** – From the Edens Expressway, take Lake Avenue west to Wagner Road. Turn north on Wagner to Winnetka Road. Turn east on Winnetka for ¾ mile. Park on the north side of the street or a side street.

**Wayside Woods Prairie/Linne RR Prairie, Morton Grove** – Meet at Wayside Woods Prairie parking lot on Lehigh Ave, a few blocks east of Waukegan Road and just north of Dempster.

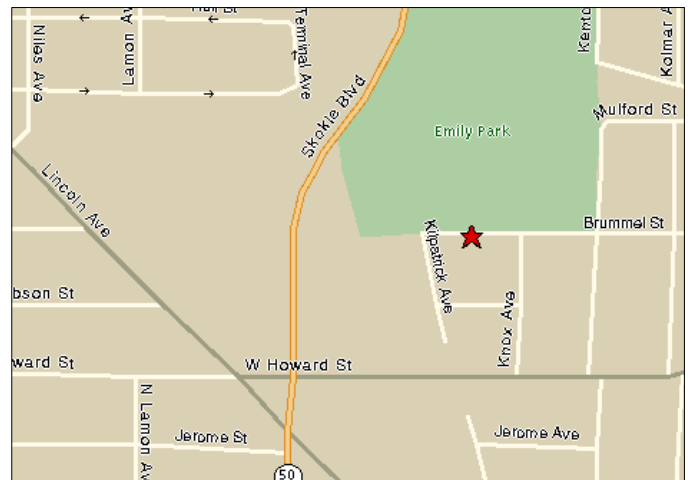
## ***ANNUAL NORTH BRANCH SEED PROCESSING DAY***

Saturday, November 20  
Emily Oaks Nature Center  
4650 Brummel St., Skokie, Illinois, 60076  
9:00 am until mid-afternoon

Join us as we process the vital seeds that have been collected over the summer and fall. Carefully gathered and stored by knowledgeable volunteers, the seed of over a hundred native species will be readied for return to the Forest Preserves, where populations of native grasses, sedges and wildflowers will be reestablished.

Drinks are provided, but many of us also bring a dish to share during breaks from the work. The activities start at 9:00am and continue until the seed has been processed, usually by mid-afternoon.

**Directions to Emily Oaks Nature Center:** from Skokie Boulevard/Cicero, go east on Howard St. to Knox Ave. Turn north on Knox, go two blocks to Brummel St. Turn west and go one block to the parking area at the Nature Center, on the north side of Brummel. Follow the signs to the processing area.
